Enrollment and Tuition Contract

Parents are responsible to carefully read and adhere to this Summer Enrollment and Tuition Contract.

- I understand that Summer tuition is due on the first of every month, for attendance during that month.
- I understand that a late fee of \$25 will be assessed for payments received after the 1st of the month.
- A \$25 service charge will be applied to my account for returned checks.
- If my child is not picked-up from school by 6:00pm, I understand I will be charged \$1.00 per minute after 6PM, increasing to \$2.00 for every minute after 6:30pm.

Late Pick up Policy

Students must be picked up no later than 6:00 p.m. A late charge of \$1.00 per minute will be assessed up until 6:30 p.m. After 6:30p.m. and \$2.00 per minute fee will be assessed; it must be paid at the time of pick up. If a parent is more than one hour late we may be required to call Child Protective Services. Repeated lateness may result in the dismissal of a student.
